# **NEW BUSINESS:**

Councilman Levy suggested that applicants receive a builder's package specific to requirements of each department. A discussion ensued concerning the Planning Board checklist for applicant's to follow and possibly amending it to include additional items required by the departments.

The Board discussed the timeframe in which sewers will be installed in the downtown area. Councilman Levy responded that it could take up to 5 years or more and reviewed the planning involved in order to get things going. They discussed the condition of the sewage treatment plants and what it would take to decommission them.

Mr. Russo informed the Board that Thomas Battersby is still interested in developing the Ramapo Motel property. Councilman Levy expressed that Mr. Battersby does not have much time left before the Ramapo River is categorized as a C-1 stream some time at the end of August. Once

the Ramapo River categorized a C-1 stream, this will place many constrictions on any development.

Mr. Russo informed the Board that the ordinance holding up the Smith property has been amended and they will return to the Board with their subdivision in September.

Chairman Potash suggested that the Downtown Committee meet in September. Mr. Lydon informed the Board where they are in the grant process. A discussion ensued concerning the DEP slowing down the process to improve the downtown area due to no sewers and impervious surface. They may need incorporate more green development. Mr. Rose offered his help in the green development.

It was discussed and decided that the Planning Board meeting on August 8<sup>th</sup> will be canceled.

### **OLD BUSINESS:**

Again, Chairman Potash suggested that the sub-committee read over the material and maybe at the next meeting, they will be in a better position to schedule a meeting. Mr. Rose offered his help whenever they need it.
