NEW BUSINESS:

1. Shed and Pod Ordinance Discussion

Mr. Hagberg expressed that the Pod and shed ordinance needs to be better defined. The building department has been receiving shed permit requests for shipping containers from residents and landscapers. He expressed that the ordinance is vague and difficult to enforce since these containers can fall under the category of a shed. A discussion ensued concerning combining the two ordinances, adding to the POD ordinance or expand on the definition of a shed. There was discussion concerning the material used to construct a container and adding esthetic guidelines such as a pitched roof. In addition, the name "POD" is a brand name and needs to be addressed. It was decided that Mr. Russo and Mr. Hagberg would look into redefining the existing POD and shed ordinance and advise accordingly.

2. Discussion of Central Business District Plan Addendum

Mr. Lydon gave a presentation on the amendment to the 2006 Central Business District Plan to eliminate a portion of the Oak Street extension. The amendment was sent to the county and public hearing will be held next month for possible adoption as an element in the Borough's master plan.

OLD BUSINESS:

1. Residential Complaint

There was a complaint from one of the residents living at the Oak Crest Condominiums concerning an unpainted bay door for deliveries and deliveries occurring at all different hours for the Pet Supplies Plus in the Copper Tree Mall. Mr. Hagberg would look into the matter.

2. Oakland BOE- Playground Improvements.

Mr. Russo explained that a letter was sent to the Board of Education Business Administrator informing her that based on Mr. Yakimik's review, a formal review was not necessary but suggested that his recommendations be incorporated into the plans.

3. Discuss Ordinance 18-Code-767:
