#### **NEW BUSINESS:**

Councilman Levy questioned the possibility of updating the Borough's Stormwater Management ordinance to help with future projects involving NJDEP and the Highlands. Chairman Potash questioned if that is the state's responsibility. Mr. Yakimik responded that the state has jurisdiction over stormwater management for major developments however, Councilman Levy is referring to the local level ordinance that regulates all development within the town. He commented that soil moving requirements need to be updated and suggested that the Board start that. The Board discussed the possibility of creating a schedule for residential improvements where if an increase in impervious surface is being proposed, the applicant will be required to have their application reviewed by the Borough Engineer to see if seepage pits are necessary.

Councilman Levy informed the Board that delays in getting sewers are due to requirements being imposed by the NJDEP and NWBUA which are creating a hardship for the town. A discussion ensued concerning ways to increase water recharge, the expense of purchasing water through NJ Water or Suez Water and decommissioning sewage treatment plants and wells. Mayor Schwager suggested that Mr. Yakimik get an update on sewers from Mr. Boswell and Giselle Diaz and report back to the Board. The Board agreed.
