NEW BUSINESS:

Mr. Hagberg informed the Board that he and Mr. Russo have been discussing the possibility of the Japanese School building chicken coups on the property in order to teach the students how to raise chickens. He explained that it was decided that this proposal would be an expanded use and would need board approval. It would need to go to the Zoning Board.

Mr. Hagberg explained that in the other towns he works for, the request for raising chickens for their eggs and beehives for the honey are becoming popular with residential properties. They do not allow roosters to eliminate the noise factor.

OLD BUSINESS:

Mr. Russo questioned the Board if they feel Reed Academy should go back to the Board to erect a traffic light the school is proposing to put within a portion of the parking lot to teach children with Autism how to obey traffic signals.

A discussion ensued concerning how close the traffic light would be to the main street and if it would be confusing for traffic. Mr. Hagberg responded that he discussed it with Officer Frank Fiore who had no issues with the traffic light. He explained that the light sits approximately 68-feet off Bauer Drive and the light will be on when they are instructing the students and off when there is no instruction.

The consensus of the Board was to allow the Building Department to handle as long as they make sure that it is for instructional purposes only, whether the traffic light would be free-standing, would the traffic light interfere with the street and the height of the poll for the traffic light.

Chairman Potash reminded the Board to keep an open mind and vote how you feel concerning the Roy application. This is not a team effort. Mr. Morris added that even though you are not in favor of an application, if an application meets all of the criteria, the Planning Board's job is to vote fairly.
