

**OAKLAND RECREATION COMMISSION

Open Session- As there were no public in attendance at the time of the public session, no public session was held.

Approval of previous months minutes- A motion to approve the December 2021 regular meeting minutes was made by Commissioner Hagerman and seconded by Commissioner La Terra. The motion passed unanimously.

The following reports were made and unanimously accepted.

BASEBALL – Comm. Hagerman – Registration is open. With the change of joining Little League and the governing body for the program, there has been a lot going on. First meeting with the district is this Friday. Will have more details following this meeting. There has been some confusion regarding the difference between Rec and Little League. The only difference is the name. They are the same program. Numbers will likely pick up over the next month. Chairman Guadagnino asked if the travel teams were practicing indoors this winter. Commissioner Hagerman said that he believes so and wanted to confirm that it is ok. Chairman Guadagnino said yes but we are responsible for the practices and players and need to watch closely.

BASKETBALL – Comm. Ives – Rec season continues. We are in games for all 3-8th grade levels and 1&2 are in clinic style. Travel season continues and many of our teams are doing very well. We expect teams to go into March. Currently no teams in quarantine due to COVID-19 which is great!

FOOTBALL – Comm. Hagerman – No report.

GOLF – Comm. Bleeker – We just sent out a new flyer. We can only handle about 20. Registration is now open but we are unsure on numbers yet.

ROLLER HOCKEY – Comm. Bleeker – Season is about half way over and is going well. Have had no issues so far. We have almost all of our jerseys and our jackets are delayed due to

COVID-19 back orders. The banners came in this weekend, so he will contact Councilman Van Eck to set up the new date for the council meeting.

SOCCER – Comm. Rotondo – No Report.

SOFTBALL – Comm. Logatto – Registration started in early January. Slow start but getting the word out. Uniforms have been ordered. The PO has been submitted for approval. We used last year's numbers to estimate our order for this year due to last year's delays. Parade is likely first Saturday in June.

SPECIAL NEEDS – Comm. Scalabrini- Basketball started on the 16th. It was postponed a week due to the school gyms being closed. Still having kids signing up. Going well.

TENNIS – Comm. Scalabrini – Working on Rec Tennis registrations next month.

WRESTLING – Comm. Logatto – This past Sunday was Oakland's Tournament at Indian Hills. There were 16 teams that entered. Oakland had 26 medals at this tournament. In the dual meets, they are 3 and 0. There are 13 8th graders and 10 will be going to Indian hills.

CHEERLEADING –Comm. LaTerra – Opening registration early this year end of February beginning of March. Plan to run stunting practice through the summer. The girls enjoyed and could use the extra work. Dates will be TBD.

LACROSSE – Comm. Coira – The clinic registrations are open prek -4th grade. Runs through March 15th. Saturday mornings for 6 sessions. We had an issue with the 3&4th grade boys lacrosse program but we didn't have enough kids so they went to Franklin Lakes.
