A motion to approve the Committee Assignments was made by Comm. Malmud, seconded by Comm. Logatto and passed.

The following reports were made and upon proper motion unanimously accepted:

**BASEBALL** – Comm. O'Brien – 3 out of 4 sign ups have been completed. Tomorrow night is the last one with the following week being for late sign ups which will include a \$10 late fee. There will be an absolute cutoff date of February 15<sup>th</sup> for registration. The parade will be held on May 4<sup>th</sup>. The Mayor and Council are cordially invited to attend the parade. Our goal date to finish rec season will be June 15<sup>th</sup>. Registration is slightly lighter than last year, hoping for some last minute sign ups. Travel 12U & 8U to tryout on February 3. Then all travel teams will be established.

**BASKETBALL** – Comm. Malmud – Pictures were this past Saturday. We had a 60% turnout. Rec season and travel seasons are going on.

**FOOTBALL** – Comm. Pernetti – Equipment is getting ready to go out for reconditioning by the beginning of February. Dealing with Hawthorne and they have decided not to come back. Sign-ups will be in early May.

**GOLF** – Comm. Scalabrini – No report.

**ROLLER HOCKEY** – Comm. Haas – Having a great season. All teams have a winning record. Two are in 1<sup>st</sup> place in the league.

**SOCCER** – Comm. Saliani – Would like to change youth uniforms next year.

**SOFTBALL** – Comm. Logatto – Sign ups continuing. Travel tryouts dates are up on website. Working well with baseball to get schedules in sync.

**SPECIAL NEEDS** – Comm. Malmud – Lori mentioned there is some woman that has taken over and she will send her contact information to Comm. Malmud. She came in with some purchases.

**TENNIS** – Comm. Scalabrini – Trying to put up a wall to use for handball.

**WRESTLING** – Comm. King – Had their invitational tournament which went off without a hitch. Raised money for the program. First year the new head coach was running it and he was very happy with all the parental support. He knows now what not to do next year. It went very well.

**CHEERLEADING** – Comm. Pernetti – Pom poms were found in the summer camp building.

**LACROSSE** – Comm. King – No report.

**BUILDING AND GROUNDS** – Chairman Guadagnino – There is an issue with some apparatus on the playground and it is closed until that is fixed.

**SUMMER CAMP** – Chairman Guadagnino – No report.

**SUMMER RECREATION PROGRAMS** – Comm. Malmud – Will be coordinating with Coach Light about the girls' softball program. He will be holding his clinics the last week of June and the first week of July. Then he will run basketball clinics the second and third weeks of July. Fees will be the same as last year and it will be held at IHHS.

**KINDERGARTEN CORE** - Comm. Saliani – 3 weeks left for sign ups. 60 kids are signed up. Need to better the communication between other schools – Manito comprises 80% of the enrollment. Would like to reach out to the other schools and try to get more participation from them.

## **CAPITAL PROJECTS**

Walking path – The borough is doing a spot survey because there are two different boundaries on one side of the complex, this will find out which is correct.

Pleasureland/Muellers Park – Tomorrow night will be the Town Hall meeting at 8:00 in council chambers. Second meeting will be on February 26th.

Delia Bldg. – Fathers Club is doing a lot of work inside putting up shelves. Put in PO to process for new windows. That PO has been approved by Rich and is now in by Finance. Need to get a bulletin board for the wall. Room will be locked with specific rules to help maintain the room in good condition.

Shed security system – Keys are in. Marty was trained on how the system works. There is a web based tool as to who has access to what. Lori, DPW & Mike will have a master key. Each commissioner will have key access to the D'Elia, Shed, Office and their sports locker. Each key will be programmed for the length of time that each person might need it.

## **OLD BUSINESS**

Field usage – Chairman Guadagnino read a new proposal written up by Comm. O'Brien.

Comm. Saliani mentioned that the Wildcats donated \$3000.00 for water last year for Truman field. However, Truman was barely watered last year. Their biggest need is a lighted field. There have been times where Comm. Saliani has said no to practice at the rec field due to rec teams using the fields. The Wildcats are very flexible. They offered free training for our coaches. Comm. Saliani's recommendation is that since the Wildcats paid \$3500.00 last year that wasn't used. (Lori provided the commissioners a breakdown since 2007. Their records match ours.) They should be charged upfront for their field usage of \$3500.00 including their tournaments. Cut the water charge out. They will coordinate with Oakland Rec for field usage. If they want separate field usage, then they will have to fill out a field usage permit and pay the going rate. Comm. Saliani would like to start focusing more on creating Oakland only teams. A motion to accept Comm. Saliani's recommendation was made by Comm. Malmud, seconded by Comm. Pernetti and approved.

The ice machine is broken and needs to be replaced. Need to go to Mothers/Fathers Club.
