

**OAKLAND RECREATION COMMISSION
REORGANIZATION MEETING
MONDAY, JANUARY 13, 2014**

The reorganization meeting of the Oakland Recreation Commission was called to order at 8:00 p.m. by Cheryl Logatto, with the Flag Salute, at the Danny D'Elia Recreation Center under the public sunshine laws. Commissioner's Logatto, Scalabrini, Haas, King, Perneti, Malmud, Saliani and O'Brien were present. Recreation Secretary Lori Dent and Councilwoman Sandra Coira were also present.

A nomination for Chairman of the Recreation Commission was requested. Comm. Malmud nominated Chairman Guadagnino and it was seconded by Comm. Perneti. The vote was unanimous in favor of this nomination. The gavel was turned over to Chairman Guadagnino.

A nomination for Vice-Chairman of the Recreation Commission was requested. Comm. Guadagnino nominated Comm. Logatto and it was seconded by Comm. Malmud. The vote was unanimous in favor of this nomination.

A nomination for Treasurer of the Recreation Commission was requested. Comm. Guadagnino nominated Comm. Malmud and it was seconded by Comm. O'Brien. The vote was unanimous in favor of this nomination.

A nomination for Secretary of the Recreation Commission was requested. Comm. Logatto recused himself from voting for Secretary. Comm. Malmud nominated Cheryl Logatto and it was seconded by Comm. Scalabrini. The vote was unanimous in favor of this nomination.

Comm. Guadagnino will make revisions to Bylaws and will be finalized at the next Rec meeting.

Field lighting – Going to be completed by April 30th. Will be done in segments starting around March 10. Fields 1, 2, 3, 4, & 6 will be done in March. All scoreboards will be rewired. Commissioners will be trained on which lights will go on for each sport.
