

**OAKLAND RECREATION COMMISSION**  
**MINUTES OF REGULAR MEETING**  
**Monday, April 29, 2019**

The regular monthly meeting of the Oakland Recreation Commission was called to order at 8:02 pm by Chairman Guadagnino, with the flag salute, at the Danny D'Elia Recreation Center under the public sunshine laws. Commissioners Guadagnino, Laterra, Logatto, Saliani, and Nittoli were present. Councilman Kulmala was also present. Commissioners Coira, King, Walker, and Scalabrini were absent.

A motion to approve the minutes from the March 25 regular meeting were made by Commissioner Saliani and seconded by Commissioner Logatto.

**Open Session-** Seeing no one in the audience from the public there was no open session.

**The following reports were made and in proper motion unanimously accepted.**
