The Reorganization and Regular Meeting of the Borough of Oakland Environmental Commission opened on Tuesday February 8, 2022 at 7:31 p.m. via Zoom Video Conferencing.

COMMITTEE REPORTS:

Borough Council: Councilman Pat Pignatelli reported that the Borough is pursuing charcoal as an alternative treatment for the PFOS water upgrades. The other consideration was reverse osmosis. Chairman Lee Haymon suggested that a call is scheduled with the Borough Professionals and Environmental Commission representatives for discussion on the treatment plan and how the decision was made. Michael Carelli will work on scheduling a meeting. Councilman Pignatelli added that federal funding is pending for such projects.

Open Space: Councilman Pignatelli added that the seller of Sandy Beach is not cooperative and a willing seller. Erich Kamm suggested that Councilman Pignatelli take on open space reports moving forward. The Commission praised Mr. Kamm's knowledge on open space acquisition and practices. It was determined that the Commission keep pursuing open space acquisition moving forward.

Great Oak Park: Chairman Lee Haymon announced that the Park Committee will be meeting for the first time in 2022 this month.

Green Team: Michael Carelli reported that the new plastic bag ban law will be coming into effect on May 4, 2022. For more information, visit www.bagupnj.com. The Oakland Community Garden registration will be announced in the coming weeks on the Borough website.

Planning Board/Board of Adjustment: Councilman Pignatelli added that the Borough Council reversed the Board of Adjustment's decision on the use variance for Elahi Fuel. This was the first time this has happened.

GIS Map: Matthew Shook reached out to the NY/NJ Trail Conference for potential assistance with the GIS mapping project. A potential app was discussed for use by students.

Board Vacancy: Michael Carelli reported that the Commission has one (1) Board Vacancy currently and the Commission is seeking new members.

Alex Myers Certificate: A certificate honoring outgoing Commissioner Alex Myers will be read at the February 9, 2022 Borough Council Meeting by the Mayor.

Annual Accomplishments Report: The 2022 Annual Accomplishments Report was distributed to the Commission and will be read aloud at the next Borough Council Meeting.

Cleanup: A Borough Clean Up has been scheduled for April 30, 2022 from 9:00 a.m. – 12:00 p.m. Lee Haymon is taking the lead and will coordinate volunteers. Michael Carelli will work on public outreach and a flier. Michael Carelli will apply to the Bergen County Clean Communities Grant to fund the program.
