Commission meetings are held on the last Monday of each month. You must submit your application a minimum of 4 weeks prior to your requested dates to enable fair scheduling.

Notwithstanding the foregoing, however, the Hold Harmless Agreement shall be applicable to any Claim asserted against the Borough of Oakland or any loss incurred arising out of the applicant's activity, whether or not the same extends beyond the permitted type or locale of activity or occurs on a different date than specified.

6. The applicant specifically agrees that this indemnification and Hold Harmless Agreement shall include the responsibility to provide legal defense for the Borough of Oakland for any suit arising out of the applicant's use of the recreation facility, and that, should the applicant or the applicant's insurance carrier fail or refuse to provide such a defense, the applicant will reimburse the Borough for any costs incurred by it for any person or organization acting on its behalf.

By Ordinance:

No Alcoholic Beverages are permitted on any Recreation Facility grounds including parking lots.

No Dogs are allowed on any Recreation Field.

All other Borough and New Jersey Laws and / or Ordinances apply.

No Smoking is permitted on any recreation property including parking lots.

Rules:

No Batting or Pitching Balls into fences within the recreation facilities

You are responsible for cleaning up after yourself.

Gambling or games of chance are not permitted.

If using the facilities at night, turn off lights if you are the last group to leave.

Danny Delia building must be empty of all trash, carpet vacuumed (*vacuum is in the corner of room*), chairs & tables stacked as when renter arrived and lights shut off.
