#### MAYOR'S REPORT:

Mayor Kulmala reviewed the status of the Borough of Oakland's current projects:

- Mayor Kulmala stated that the Water PFOA treatment is on schedule, Well 10 is online since last Tuesday and had a no detect on PFOS chemicals. Well 5 will be up and running by the end of the week, probably Thursday.
- Mayor Kulmala stated that the Lakeside Boulevard Water Main and the Sewer Main work is also completed.
- Mayor Kulmala advised the residents on Lakeside that the equipment will be demobilized, and paving will be done in the spring.
- Mayor Kulmala thanked the residents that donated Blood for the Mayor's Wellness Campaign.
- Mayor Kulmala announced that the Band Shell's electrical work is nearing completion. The Band Shell will be ready for the Grand Opening in June.
- Mayor Kulmala announced that Ed Clark a volunteer, who is a landscape architect has started to work on landscaping ideas for the Van Allen House.
- Mayor Kulmala stated that the Lennar Developer Agreement has not been signed yet. It will
  be signed by the end of the week after the Borough attorney, Engineer, Administrator and
  Professionals review the document.

Dan McDonnell, 56 Lakeview Terrace, stated that inspectors need to be out there watching the work that is being done, he sees contractors cutting corners. He also stated there is a 5x5 hole in need of repair ASAP.

Frank Ritacco 51 Lakeshore Drive, stated that a group of lakefront homeowners on Crystal and Mirror Lakes are looking for a solution to the challenges being faced. He stated a large number of residents of RML believe that the lakes are an asset to the Borough of Oakland. He thanked Mayor Kulmala and Mr. Kunze for meeting with the group. The group is looking into forming a nonprofit to take over the lakes.

Michael Pritchard 23 Calumet, stated that Allerman Brook goes through Franklin Lakes. He believes the DOT has caused the issues at Allerman Brook.

Adam Elkin, 1472 Lakeshore Drive, storm water has an effect on RML Crystal Lake, the dam needs repair. He stated let's use the assets in the best interest of the town.

Sheila Boylan, 16 Walnut Street, Stated she is having flooding on her property and has lived and owned it for 48 years. Without flooding. She is frustrated and needs help to figure out what is causing the flooding. She stated she would like to see Crystal Lake preserved.

**WHEREAS,** Mayor Eric Kulmala has nominated the firm of Acrisure to serve as the Borough Risk Manager for Health Benefits for the year 2024; and

**WHEREAS,** the Borough has received or will receive a Business Registration certificate and Affirmative Action compliance statement from the firm prior to entering into a contract;

**NOW, THEREFORE, BE IT RESOLVED,** by the Borough Council of the Borough of Oakland, in the County of Bergen, and State of New Jersey, that the firm of Acrisure be and is hereby appointed as Borough Risk Manager for Health Benefits for the year 2024; and

**BE IT FURTHER RESOLVED,** that compensation for said Borough Risk Manager for Health Benefits for the year 2024 shall be claimed, approved and paid in the manner set forth in N.J.S.A. 40A:5-18 and pursuant to agreement to be entered into between the parties; and

- Commission on the Life premium of 7.5% with payment being made to the Acrisure by the carrier.

- Commission on the Short Term Disability Premium of 10% to be paid directly by the carrier.
- Commission on the Long Term Disability premium of 15% to be paid directly by the carrier.
